## Benefits

## Fees, Qualification and Application

Membership fees are €80 for a full year (from 01 July to 30 June). New members joining from January will pay a prorated fee of €40. Candidates must be currently enrolled in the CFA, RBA, RMFI or CIPM program.

**CFA and CIPM Candidates** must have been registered for an exam in the course of the last three years. **Charter Pending**
